- All material uploaded must be submitted to submission@MusicArtists4U.com.
- Only MP3 format at 128 bit or higher will be accepted.
- All submissions will be reviewed by the MA4U review board.
- Inclusion to the MA4U streaming music player will be dependant on quality of recording and lyric content.
- No MATURE LYRIC submissions will be included in the MA4U streaming digital music player.
- Each applicant will be notified upon acceptance to the MA4U streaming digital music player.

Accepted Submissions

- All songs must be delivered in CD format
- All CDs must be labeled with name, address, phone and email of applicant and copyright owner.
- All CDs must be accompanied by the MA4U Streaming Digital Music Player Submission Form available in PDF format on the MA4U streaming digital music player website.
- All CDs submissions must be accompanied by the MA4U streaming digital music player PERMISSION OF USE/GRATIS DIGITAL STREAMING LISCENSE agreement available in PDF format on the MA4U streaming music player website.

MA4U Streaming Music Player Terms of Use

- MA4U streaming digital music player does not pay streaming fees
- Only material covered by the MA4U streaming music player PERMISSION OF USE/GRATIS STREAMING LISCENSE agreement will be included in the MA4U streaming music player play list.
- MA4U streaming digital music player is not a signatory of or affiliated with any music unions (AFM, AFTRA) nor is it a signatory or affiliated with any performing rights / royalty distribution companies (ASCAP, BMI, SESAC)
- All fees relating to the above mentioned and other union, royalty any other collection agency will be the sole responsibility of the copyright owner/accepted applicant, hereafter referred to as PERSON OF RECORD.

Music Sales and Payment

- All music included in the MA4U streaming digital music player will be offered for digital download through the MA4U website
- The MA4U streaming digital music player will issue monthly statements, in PDF format, to the PERSON OF RECORD for each unit/download sold.

- **The MA4U streaming digital music player will pay monthly, to the PERSON OF RECORD, for each unit/download sold.**
- **The PERSON OF RECORD will determine the sell price of each submission included in the MA4U streaming digital music player play list.**
- **The MA4U streaming digital music player has a set minimum of .99 cents per download**
- **MA4U streaming digital music revenue be distributed as described: 75% paid to the PERSON OF RECORD in a monthly distribution statement and 25% retained by MusicArtista4U.com .**
- **The PERSON OF RECORD will be responsible for all fees due to other entities (ie.AFM, AFRA, BMI, SESAC, ASCAP, Publishers, Co Publishers, Publishing Administration, Record Company, ect.)**
